| <p><b>Scheduled School Hours:</b><br/>Students <u>do not</u> physically attend school for any portion of the day = <b>ABSENT</b></p>  | <p><b>Asynchronous</b><br/><b>SECONDARY E/O SCHEDULE</b> (VSA Students follow VSA Schedule Guidelines):<br/><u>During traditional school hours</u>, students have <u>meaningful contact</u> via online platform, Student Vue, emailed assignment, uploaded assignment, phone conference, text message pertaining to class/assignment, etc. for a class <u>that may or may not be scheduled that day</u> = <b>PRESENT</b> for the day and for that class period the day (or counted as present for class on the day before or day after)</p> <p><b>OPTIONAL:</b><br/>Students have <u>meaningful contact</u> via online platform, Student Vue, emailed assignment, uploaded assignment, phone conference, text message pertaining to class/assignment, etc. <u>after traditional school hours</u> = <b>PRESENT AND TARDY</b></p> <p>Students who do not have meaningful contact on asynchronous days = <b>ABSENT</b></p>  |
