# Central School of Practical Nursing Financial Aid Information

### **CSPN Tuition**

Tuition for CSPN Level I students is divided into two semesters of \$2,100 each. Tuition is due on the first day of class, September 3/4, 2019 and the second payment is due by January 31, 2020. If you have been approved to receive any type of financial aid from an official outside agency/organization, you must show confirmed evidence of this by the tuition deadline. You will not be allowed to attend class if your tuition obligation has not been met by the first day of class. Payments (self-pay or other) may be made by money order, cashier's check, or in cash.

\*Scholarships and personal loans are accepted. Please ensure they are made payable to "Central School of Practical Nursing".

### Types of Financial Aid

**FASFA Grants**- Federal student aid from the U.S. Department of Education (ED) is money to help you pay your education expenses at a college, career school, university, or graduate school. The government provide more than \$150 billion in federal aid every year to those who qualify. The quickest way to apply for federal student aid is online at fafsa.gov, where you will find the Free Application for Federal Student Aid or FAFSA®. Student aid funds that do not have to be repaid.\* Most federal grants are based on financial need. https://fafsa.ed.gov/

**Opportunity Inc.-** Opportunity Inc. oversees federally funded workforce development programs, which assist businesses in accessing qualified workers and jobseekers in finding suitable job openings and bolstering their earning power through training. Their primarily interested in occupational skills training programs related to occupations in the Healthcare, Information Technology, Transportation and Distribution and Advanced Manufacturing. Industry Sectors. Students must complete and application and bring in required paperwork to qualify for funds.
