Dear Parents and Families of Larchmont,

Standards of Learning (SOL) tests continue to be required by the Virginia Department of Education (VDOE) and the United States Education Department (USED) for the 2020-2021 school year. Elementary and middle school students will test as required by their enrolled grade level and high school students will test according to the verified credits they require for graduation. In accordance with VDOE guidelines, all tests must take place in-person. If a student is enrolled in full-time virtual instruction throughout a division testing window, their school regarding testing and transportation details will contact them.

Testing Schedule

Writing SOL tests will be administered throughout March for all students enrolled in English 11 and any re-testers who continue to require a writing verified credit in high school. Reading, Mathematics, Science, and History tests will be administered May 10th through June 4th for students in grades 3-EOC (high school). Each school will communicate their detailed testing schedules with families as they are developed. Below are the division SOL testing windows.

The results of the 2020-2021 SOL tests will be used to evaluate the impact of the pandemic on student learning as well as a means to establish a new baseline for measuring future student growth. For the

2020-2021 school year, NPS will discontinue the administration of expedited retakes for grades 3 through 8 SOL tests. Retakes for EOC tests will continue as needed for those students who require the verified credit for graduation.
